Kati, Government SR: event updates

(**Kendall**) Susie was nominated for Volunteer of the Year – congrats Susie! (**Susie**) Red Ribbon Week bracelet order placed, attended CCI meeting. Spoke with Marcus, he said "We will be able to meet the request just not at this time." (**Hailey**) Will send a final deadline email. (**Susie**) Jeri Gowen passed away. (**David**) Jeri Gowen ran Prevention Associates and she funded 2CDFC, she has been battling cancer the last couple years. (**Kendall**) She was very positive, and she was a huge prevention advocate. (**Susie**) <u>Awkward Conversations</u>, third season of this video podcast. It's really great common-sense conversations for parents in regards to what they should discuss with their kids. It's on YouTube. Community Coalitions of Idaho is going through some pains and we are trying to get some gains. Steve Myer is going to join the board. He has a PhD in Alcohol and Drug Abuse and he is going to help us put everything back together. We are still alive and trying. I did a gallery walk-through of the mega brain. There were 7 kids there. Brought the surveys and they wrote exactly what I said when I was teaching them. Went with Earl to WASD Planning Meeting, I'll let Earl discuss. FYIdaho Uniquely You Workshop, Brenda it was amazing, thank you for the opportunity. Idaho Conference on Alcohol and Drug Dependency (ICADD), key take-aways difference between envision and empower. We want people to visualize their power and I liked that terminology change. Project Impact STEM Academy, implemented CATCH My Breath, and had all their parents come to see what their kids did during the school year. 150 adults attended and went through our booth.

Robert, Law Enforcement SR Earl, Parent SR: WASD planning, Treasure Valley Worship (Brenda) Thank you to everyone who attended the Children's Mental Health Acceptance Week festival, great turnout. Really great way to connect others. Great opportunity for the kids, got to see a community come together. Region 4 Behavioral Health Board meeting was not held for the month of May, it will be back in June. As for the Uniquely You Presentation, a proposal for the conversation was accepted today so we will be national presenters.

(Robert) performance recognition at MPD awards banquet. No updates.

(Earl) Attended a planning meeting at WASD. Changed the perspective on how to get parents involved. Hoping to attend sporting events to get more involvement. Having MADC at all their high schools, at least for their football teams and Reality Town. We would have access to the kids to talk with them for about 25-30 mins. 		to let our elected officials know how we feel. (Kendall) Rescheduling of Marijuana; some of the reasoning is so it's
		easier to study for the FDA process. Talked with Mayor, Legal, and Idaho Office of Drug Policy (ODP), since there is
		no change to Marijuana laws in Idaho this will not affect us. The Governor is firm there will be no changes to
		legalization while he is in office. Each legislative session, there are drugs that are rescheduled and legislation has to
		be updated to align with those changes. That would be the only change in Idaho if marijuana is rescheduled. For
		other states, it will change marijuana retailer's business and taxes. (David) Next week is an election, reach out to

1		information for when someone has been cited. There is definitely data out there. (Kendall) Spoke with Greg			
		Munson, who oversees these operations and learned how he reported the data to the DEA. He does regular			
		compliance checks, it's only with licensed retailers and there are vape shops that are not licensed. (Kati) It's from a			
		pool. (Earl) Is the licensing of these shops' voluntary? (Kati) I'm not sure. Permitting, if a vape shop is not			
		permitted they will get closed down. I just don't know who is enforcing this.
